- ➤ (ELECTIVE) Corporate Governance, Financial and Business Risk Management; Business Interruption Crisis Management.

Entry Requirement

- I) A Postgraduate Diploma in Enterprise Risk Management awarded within the HKU system through HKUSPACE or other equivalent qualifications.
- II) Or Applicants with other qualifications will be considered on individual merit.

This is an exempted course (Reference No.: 452797) under the Non-local Higher and Professional Education (Regulation) Ordinance. It is a matter of discretion for individual employers to recognize any qualification to which this course may lead.

Application Procedure

Applicants are required to submit the application form with supporting documents at HKU SPACE Enrolment Centers in person.

Please present the academic documents and HKID (both original and copies for verification) for the application process. Course enrolled on first come, first served basis.
