✓ **Fast route to a master's degree – “Top-up” the PCLL into an LLM**

- **120** of the requisite 180 credits for a master's degree have **already been obtained** from your Postgraduate Certificate in Laws (PCLL) or equivalent UK qualification.
- Candidates need only: view 4 pre-recorded online lectures (2 hours each) and prepare for participation in 3 real-time live online workshops, on Research Methods; write a 3,000-word Research Proposal, followed by a 15,000-word Final Dissertation.

✓ **Flexible and expedient**

- The online lectures can be downloaded and viewed at a candidate's own convenience.
- Online workshops are agreed to accommodate candidates' work schedules.
- Research can be written at a candidate's own pace and convenience.
- We admit throughout the year: Start at **any time** and complete within 1 year.

✓ **Choice of research topic**

- Candidates can propose to research in **any area** of law that interests them for the purposes of the assessed work.

✓ **Expert supervision**

- Candidates' preparation for, and production of, the assessed work will be supervised by an expert from the individual candidate's chosen field of research.
- These supervising experts are distinguished academics and practitioners, available to provide ongoing face-to-face or online support to candidates for the duration of the LLM course.
