The programme provides core private jet management and operation concepts, as well as specialized knowledge in delivering premium inflight butler services. A broad and holistic view of private jet management will be given to students with particular emphasis on hospitality service techniques.

This programme targets at:

- people who work in business aviation, business aviation centres, super yachts, private clubs, luxury and fine-dining restaurants, luxury hotels and serviced apartments, cruises, upscale catering companies, airline lounges etc; and
- hospitality practitioners and personal assistants of corporations who wish to enhance the formal butler service training.

Programme Structure

On completion of the programme, students should be able to:

- discuss the market environment and management issues of private jet business;
- explain and describe core private jet operational procedures;
- describe the professional customer service standard of private jets;
- illustrate the preparation and serving skills of food and beverage on board the private jets; and
- identify the roles, attributes and responsibilities of a private jet flight attendant

The programme also introduces a wide range of operational environments of business/private aircraft in different places (e.g. Hong Kong, The Greater China, US, Europe, Middle East, Africa). This programme is supported by The Asian Business Aviation Association (AsBAA). Graduates of these programmes will be awarded within the HKU system through HKU SPACE. For CertMod (BAIO), the certificate parchments will also be signed by AsBAA.
