# **Application Procedure**

Submit the following documents in person to HKU SPACE enrolment counters.

- 1. Application Form and a crossed cheque for HK\$200 application fee (Non-refundable) payable to "HKU SPACE".
- Certified photo copies of full educational certificates and transcripts (please produce originals of the documents for certification upon admission at SPACE Learning Centre);
- 3. Testimonials or other documentary proof of the applicant's working experience for non-standard admission requirements.

After screening the documents, programme team will inform student by email for paying the course fee.

- 1. Please submit the Enrolment/Payment Slip and a crossed cheque payable to "HKU SPACE" to enrolment counter. Credit card (VISA / Master) payment are also acceptable at enrolment counter.
- 2. Course fee should be paid by semester;

### Note:

- An application form without copies of supporting documents <u>WILL NOT</u> be processed. You will be required to produce originals of the documents for certification upon admission to the programme. Payment for application fee and course fee by credit card (VISA / Master) are also acceptable.
- Applicants are required to provide a HKID card for admission assessments and student records. Applicants will be asked to present HKID for verification if applying in person at enrolment counters or to attach a copy of HKID if applying by post.

## Notes to Non-local Applicants

To study in Hong Kong, all non-local applicants are required to obtain a student visa issued by the Immigration Department of the HKSAR Government, EXCEPT for those admitted to Hong Kong as dependants, or on a Permit for Proceeding to Hong Kong or Macao (also known as "One-way Permit"), or under any of the schemes indicated in paragraph (I) below, who do not need prior approval before taking up full-time and part-time studies. Non-local applicants who are issued with a valid employment visa or training visa, or members of the Consular Corps, or foreign domestic helpers, or admitted under any of schemes listed in paragraph (II) below, also do not need prior approval to pursue part-time studies. It is the responsibility of individual applicants to make appropriate visa arrangements. Admission to an HKU SPACE academic programme/course does not guarantee the issue of a student visa. Applicants may wish to note that part-time courses are not considered by the Immigration Department for student visa purposes except for self-financed, part-time locally accredited taught postgraduate programmes awarded within the HKU system through HKU SPACE. For non-local applicants for all courses/programmes, as their visa/entry permit status may be subject to changes from time to time, and if they select to apply in person, are required to have their H.K.I.D.
