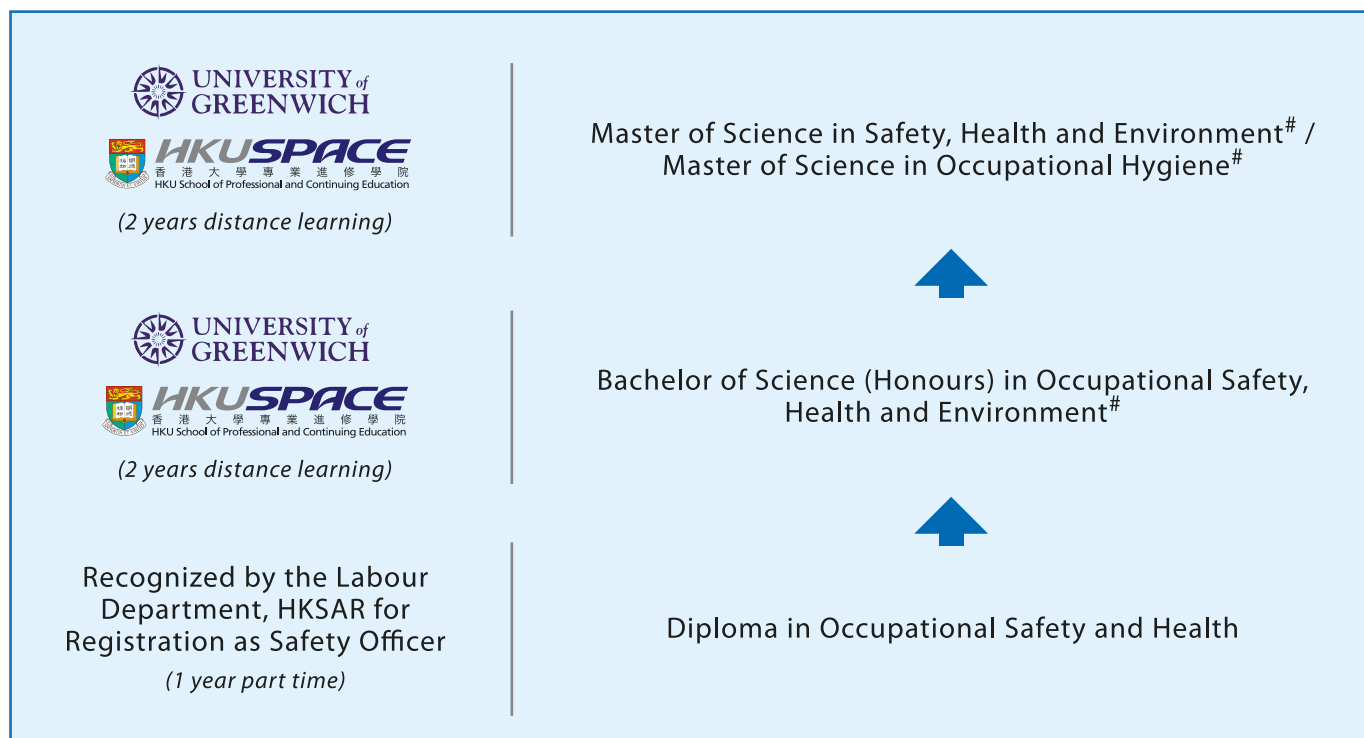

It aims to develop the students' research and analytical skills and encourage a wider and more in-depth understanding of health, safety, and environmental issues. As international programmes, they will provide the skills and knowledge required in an increasingly globalised profession producing graduates able to contribute to the creation of safer, healthier and more environmentally conscious workplaces

### **Why these programmes?**

### **Entry Requirements**

Applicants are expected to possess a bachelor's degree in the physical science discipline awarded by a recognized university.

Applicants who are members of an appropriate professional body and have appropriate professional experience may also be considered on an individual basis.

All applicants will be expected to demonstrate a proficiency in English such as IELTS with a minimum average score of 6.0 or TOEFL with a minimum score of 550; applicants who do not satisfy the minimum English proficiency requirement may be required to attend an interview or take an English enhancement course. This requirement will not apply to applicants who hold a qualification studied in English at an appropriate level.

## Bachelor of Science (Honours) in Occupational Safety, Health and Environment<sup>#</sup>

The programme aims to produce an individual with competence across the core disciplines of environment, safety and health practice. In particular, it aims to engender the necessary skills for managing environment, safety and health activities, and will encourage a 'team' approach in environment, safety and health practice. As an international programme, it will provide the skills and knowledge required in an increasingly globalised profession producing graduates able to contribute to the creation of safer, healthier and more environmentally conscious workplaces.



### Why this programme?

- The programme is currently accredited by the Institution of Occupational Safety and Health (graduate membership) and the British Occupational Hygiene Society (certificate level).
- You can
  - have face-to-face contacts with the UK tutors and local experienced scholars and practitioners;
  - choose your study period: between 2 and 3 years;
  - use both the electronic learning resources of the University of Greenwich and those of HKU;
  - have the borrowing right of HKU library; and
  - work closely with industry experts who supervise your dissertations for one whole year.

### Entry Requirements

Applicants shall a) (i) hold a degree or equivalent in an appropriate subject, for example construction, transport, logistics or healthcare; or (ii) hold appropriate professional qualifications, for example the National Examination Board in Occupational Safety and Health (NEBOSH) Diploma, or registered safety officer recognized by the HKSAR, or equivalent, with professional experience in the occupational safety and health (OSH) field; and b) provide evidence of English proficiency such as IELTS with a minimum score of 6.0 or TOEFL with a minimum score of 550, or equivalent. Applicants, who do not satisfy the minimum English proficiency requirement, may be required to attend an interview or take an English enhancement course.

## Diploma in Occupational Safety and Health

This is a well-structured programme for those who are working or planning to work in the field of occupational safety and health and wish to become a Registered Safety Officer in Hong Kong.



It provides students with fundamental and comprehensive professional training in dealing with Occupational Safety and Health (OSH) matters, and equip them to participate effectively in resolving OSH problems in both the public and private sectors.

### Programme Structure

This is a part-time face-to-face programme of one year. A student has to study 4 modules and fulfill the coursework and examination requirements. Normally two site visits are organized each year to reinforce students' knowledge learnt in lectures

### Programme Recognition

This programme is recognized by the Institution of Occupational Safety and Health (IOSH), the Hong Kong Institute of Occupational and Environmental Hygiene (HKIOEH) and the Labour Department, HKSAR respectively.

### Entry Requirements

Applicants shall a) (i) have gained in the HKCEE grade E in 3 subjects, level 2 in Chinese Language and Level 3 in English Language; or (ii) have gained in the HKDSE Examination level 2 in 4 subjects (including Chinese Language) and Level 3 in English Language; or (iii) be aged at least 23 and have gained Level 3 in English Language either in HKCEE or HKDSE Examination; and b) have 2 years of relevant work experience.
