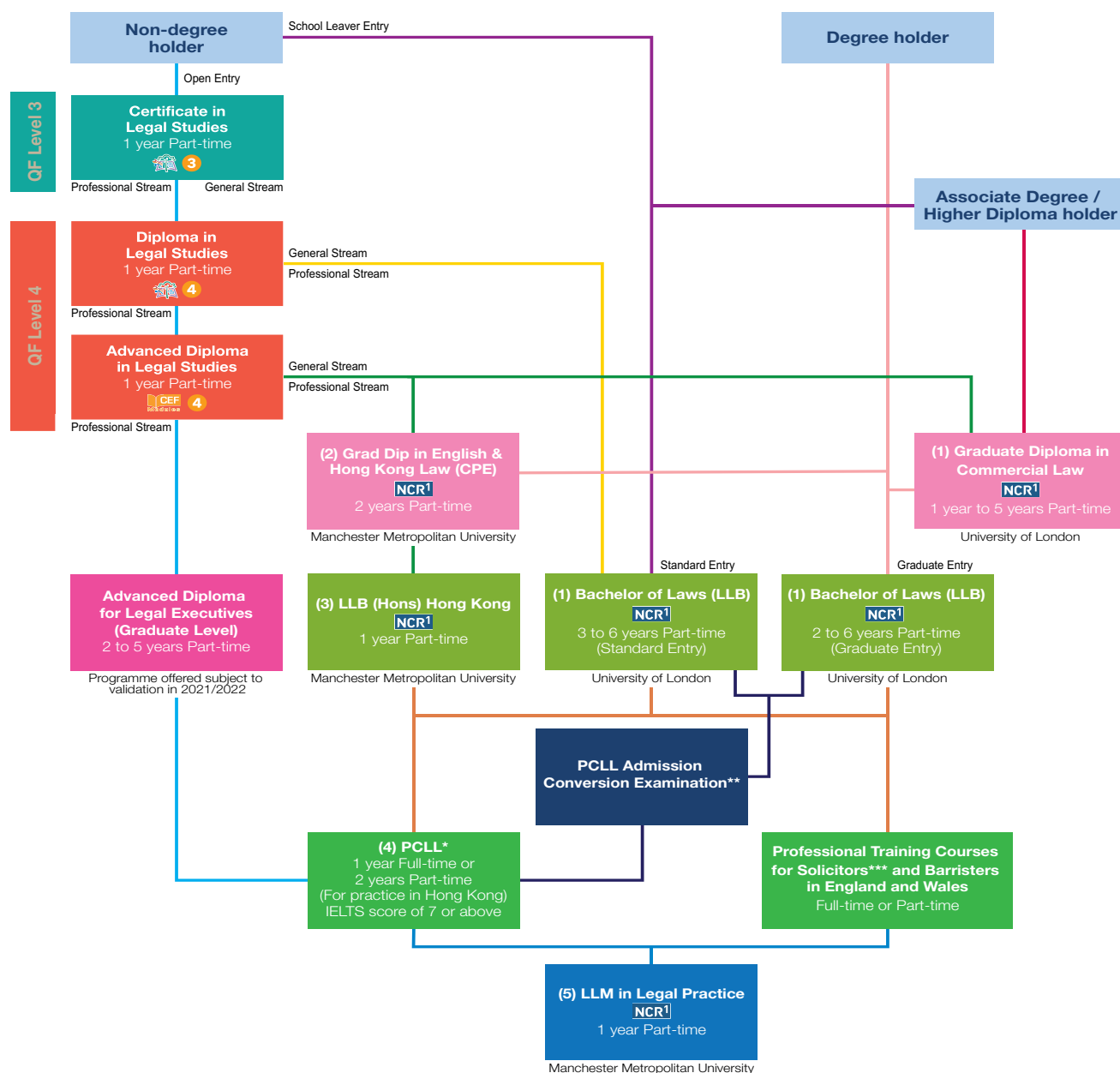

### Academic and Professional Progression



After the HK PCLL or the UK's Professional Training Courses, students proceed to the trainee solicitorship or pupillage stage in order to qualify as a solicitor or barrister.

The Graduate Diploma in English and Hong Kong Law (CPE) offers a unique—and affordable—route towards legal practice in both Hong Kong and England & Wales. For more than 25 years, the programme has been one of the most popular pathways for degree holders in other disciplines to switch to a legal career, with large numbers of graduates now working as successful solicitors, barristers and, in some cases, even judges. This one year programme for HKU SPACE students leads to an LLB (Hons) Hong Kong awarded by Manchester Metropolitan University, and gives exemption from more PCLL Conversion examinations than almost any other English law degree.

**R** The LLB (Hons) Hong Kong is for students who have completed the Graduate Diploma in English and Hong Kong Law (Common Professional Examination) taught at HKU SPACE and awarded by Manchester Metropolitan University.

Priority for admission is given to students who have completed the Graduate Diploma in English and Hong Kong Law (Common Professional Examination) at HKU SPACE. Applications will only be considered from students who have completed other Graduate Diploma in Law programmes if spaces are still available after giving first priority to HKU SPACE students.

Students who have previously studied this programme are not eligible for admission for a second time.

It is a qualification in its own right and is suitable for students who are eligible for admission to the University of London LLB but do not wish to register for the full degree, or require a bridging qualification for entry into a postgraduate programme, or wish to enhance their existing qualifications. Preparation courses are offered to help candidates prepare for University of London Graduate Diploma in Commercial Law examinations. The preparation courses cover all compulsory and some optional modules.

Commercial law

TWO optional modules offered: Alternative Dispute Resolution  
Company law

Upon completion of the programme, students should be able to:

- identify key legal issues affecting banking and commercial practices in Hong Kong;
- gain an updated knowledge on commercial law in Hong Kong and Mainland China; and
- design and implement legal risk management plans to combat commercial crimes and money laundering activities.

- R** - Applicants should hold a Bachelors Degree awarded by a recognized university or equivalent; or relevant professional qualifications.
- Applicants with other qualifications or substantial senior level / managerial work experience in accounting, law, auditing, finance, banking, government, risk management, or related areas will be considered on individual merit.
