

The 18-month programme is designed as a professional training of counsellors who specialize in Buddhist Counselling. It is the first of its kind in Asia. The Programme signifies the birth of a recognized profession of Buddhist Counsellors who have reached professional competence in the provision of individual and group counselling services, counselling visits, Buddhist homiletics, and meditation guidance in hospitals, homes for the aged, and other community settings.

The master's degree in Buddhist Counselling from The University of Hong Kong or equivalent (graduate degree from an accredited college, university, or theological school in Buddhist counselling or Buddhist Chaplaincy or Buddhist related area of counselling or other closely related areas).

Original/certified copy of the Examinee's score record will not be accepted; OR
